PRIM/PRIT

Chief Executive Officer, Michael Sacco ("CEO") informed the Board that he had attended the Investment Committee meeting on February 4, 2020. Corona virus affecting the market and it is creating a little panic. We are independent from other countries. The CEO went on to explain that it's a simple case of earnings. Companies who invest in the global market e.g. Apple, Coca Cola etc. have personnel in other countries and the market will drop.

CEO informed the Board, closed year end and will forward the breakouts to Worcester Regional's Actuary, Lynda Bournival. Mr. Sacco would like to discuss with Ms. Bournival his view regarding "access on the units. The Board proposed a vote to assess a payment plan excluding Enterprise Funds.

LEGAL LEGISLATIVE

- 1. Robert Desrosiers Town of Paxton Police Chief (Retired) Regular compensation issue briefs filed, waiting on DALA decision.
- 2. Marcia Langelier Was found guilty of \$250,000.00 of fraudulent misappropriation of funds. At sentencing she said she could pay restitution. She has served one year in jail. At the hearing, February 25, 2019 she stated she cannot pay the full restitution. WRRS has \$30,000.00 and will be directed to the town. According to the mis-appropriations statutes, Marcia is not eligible to receive anything.
- 3. Robert Kane FF/EMT in Southboro left work 2012 due elbow injury, never returned, filed ADR based on PSTD Board denied DALA affirmed CRAB affirmed in part, remanded in part ADR for PTSD waiting on clarification motion decision.

- 4. Anthony Belliveau Millbury PD placed on administrative leave December 2015 never reported psych problems investigation into removing firearms from safe at work. Files for ADR PTSD similar to Kane denied reason stop working was his being placed on Admin Leave, not PTSD pending at DALA, post hearing briefs filed.
- 5. Christopher Hackett DALA appeal filed, denial on Heart Law Treating Physician answered no, congenital defect; and
- 6. Kevin Sanko CRAB remand, pending at DALA on misconduct issue
- 7. Gomes SJC issues. PERAC issued a memo regarding the same. Will let you know how it all shakes out.

CHIEF EXECUTIVE OFFICER REPORT

1. The CEO proposed an RFP for due diligence regarding Pension Investment. The packet of information is in the February packet. We will be advertising for two weeks on the PERAC website, Secretary to the Commonwealth and Telegram Gazette.

The proposal will read twenty hours (20) a week; instead of 1040, and part-time will consist of fifteen (15) consecutive months and would send our new policy out to all the Units next week.
